TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. The promoter is TEG Sport (ACN 654 218 934) of Level 3, 175 Liverpool Street, Sydney, NSW 2000 (**Promoter**).
- 3. The competition is 'Dabble Darts Best Dressed', held during the Dabble Darts | ANZ Premier League event held in Australia (**The promotion**)
- 4. This promotion is conducted in connection with the online sale of tickets by the Promoter to the Dabble Darts | ANZ Premier League 2025 (**Event**).
- 4. Entry is only open to residents of Australia who meet the minimum age restriction advertised for the Event and are authorised to purchase ticket(s) to the Event (**Entrants**).

At the MC's discretion, the participant(s) with the loudest cheer from the crowd are deemed the winner(s). The winner(s) will be notified at each Event. The Promoter's decision is final and no correspondence will be entered into. (**Entry method**)
